## LEGITIMATE ARRANGEMENT

Dear Sir,

I am Barrister Jabu F. Thevedi, the Principal Partner of above Law Firm. Our company is also a specialist in Property management. I would respectfully request that you keep the contents of this mail confidential. I would like to intimate you with certain facts that I believe would be of interest to you in anticipation that you will make-out time and read my message carefully and reply to me with swift disclosing your intention to partner with me in this deal.
